COMMENT

Vehicle manufacturer commits that all mandatory tests compliant for the vehicle configuration tested are the same implemented in all vehicle configurations declared as included in the label. Vehicle manufacturer shall declare the list of compliant optional test implemented for each vehicle configuration included in the label. Vehicle manufacturer shall declare any change impacting the result of one or several tests for each vehicle configuration using the "declaration of change" file available on ITxPT documentation center.

For articulated vehicle with Gas engine type configuration, the main enclosure is splitted into two connected areas with terminal block in between, with 60L dedicated to ITxPT enclosure. Complete FMS frames (PGNs) are available only when dashboard +15 is activated. Main switch can be implemented either on the dashboard or outside the vehicle, at the front door level.
